A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT  
RESPECTING THE JOINT PURCHASE OF A NEW FIRE TRUCK

The Council of the Town of Wolseley enacts as follows:


1. The TOWN OF WOLSELEY is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "A", with the RURAL MUNICIPALITY OF WOLSELEY, NO. 155.
2. The Mayor and Chief Administrative Officer ("CAO") of the TOWN OF WOLSELEY are hereby authorized to sign and execute the attached agreement identified as Exhibit "A".
3. The Order Acknowledgement dated March 1, 2018 from Fort Garry Fire Trucks shall be attached hereto and form part of this bylaw, and identified as Exhibit "B".

MEMORANDUM OF AGREEMENT made in duplicate this 17<sup>TH</sup> day of APRIL, 2018

BETWEEN:

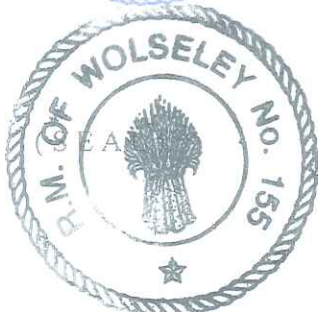
**THE RURAL MUNICIPALITY OF WOLSELEY, NO. 155,**  
in the Province of Saskatchewan  
(hereinafter referred to as the "R.M.")

and

**THE TOWN OF WOLSELEY,**  
in the Province of Saskatchewan  
(hereinafter referred to as the "Town")

This Agreement Witnesseth As Follows:

1. The parties to this agreement agree to purchase a new fire truck and essential mounted equipment from Fort Garry Fire Trucks ("F.G.F.T."). F.G.F.T. confirms the selling price as of March 1, 2018 at \$398,117.00 plus applicable taxes of \$19,905.85; and has agreed to a pre-payment discount of \$5,000.00 based on a down payment of \$300,000.00. The new total price for the new fire truck and essential mounted equipment is \$393,117.00 plus GST of \$19,655.85.
2. It is agreed that the R.M. will pay half (50%) of the total cost of the truck and retain 50% of the ownership; the Town will pay 50% of the total cost of the truck and retain 50% of the ownership. It is further agreed that any equipment purchased at the time of the truck purchase, including mounted equipment, will be cost-shared equally between the R.M. and Town.
3. It is agreed that the R.M. shall pay its share of the truck cost to the Town by way of the following:
  - (a) 50% of the down payment of \$300,000.00 totaling \$150,000.00 when requested by F.G.F.T.;
  - (b) 50% of the remainder of the balance to be paid at the time of delivery.
4. It is agreed that the truck will be operated and maintained by the Wolseley and District Fire Department with costs shared between the R.M. and Town as per agreement dated July 11, 1989 (Bylaw No. 04-1989).
5. It is agreed that should either the R.M. or Town deem it beneficial to dispose of its share of the truck it would be disposed of as follows:
  - (a) The Fire Board shall meet to discuss disposal options;
  - (b) If neither the R.M. nor Town wish to retain ownership of the truck it shall be sold at the market price for the time in question with 50% of the proceeds retained by the R.M. and 50% of the proceeds retained by the Town.
